Summary			
On date and stated above, while transporting housekeepers to the Children Learning Center, Security noticed an ambulance parked by the tennis courts with its light on. Security immediately notified the supervisor to find out if he was aware of the paramedics being on campus at this time. He stated that he was not aware of any paramedics being called to the			

athletic field. At this time the ambulance was leaving the parking lot with an injured subject. The supervisor advised the security officer to go to the Athletic Center to get as much information as possible about the situation. Spoke with the receptionist at the desk who said he knew something had happened but did not have adequate facts about the situation stating that the coaches responded to the victim. The athletic technician was also unaware of the incident that happened on the field. Advised him of what had happened on the field and that security was not notified of the incident. He mentioned that a cart was on the field if any emergencies do come up. Security advised him to let the coaches know to also notify the security department as well as the paramedics. Coaches in their response stated that the female victim was suffering from heat exhaustion that was caused by lack of liquids in her body. Coaches also gave security her fathers name and his contact number.
