On November 2, 2009, around 9:15am, a student came to the Security Office in the RCF building to report a verbal disagreement on a social website between herself and another HCC student. She stated that the first disagreement occurred about two weeks ago, but escalated on October 27, 2009 via facebook when she commented on a mutual friend's status. The other student began to verbally attack her, by calling her stupid. The other student criticized her religious beliefs, suggesting that she commit suicide and also making discriminatory remarks toward her handicapped twin sister. As described by the student, the other student is about five feet, possibly a white female and 8 months pregnant. No further information provided.

Disposition	This information is a follow up from the report that was written on 11/2/09: While in the café, Security observed a white female that was mentioned in a report on 11/2/09. Security then contacted the Leutenant of the situation, and approached the individual to identify. Security asked if her name was the one that was mentioned in the original report and she stated yes. At this time, Security escorted her to the the security office to get her information. She gave us her full name and ID #. She was informed by security that her name may have been mentioned in an incident and that we needed her last name to complete the report.

When Security spoke to the instructor, she confirmed just about the same as the student, but she says that when she asked her class to go back to their seats from the computers, the student was lacking in movement, and that she was disturbing her class, and she asked her to leave so that she can continue to teach her group. The instructor said that she doesn't want the student in her class until she meets with a student advisor or administrator. The student left without incident. No further information provided.

Letter on student's vehicle read as follows: "I'm not sure if you do this in all of your classes, but I personally find it very distracting when you talk during class. I have paid to hear what the professor has to say and would appreciate if you respect that. Also is painting your nails in class really appropriate? If you feel you have better things to do during class then listen to the teacher please feel free to do them outside of class. The class as a whole would appreciate your understanding of this matter.

In his statement, the student advised that he is "dealing with some difficult times" however admitted this was not the proper way to deal with it.
