In March 2020, Congress passed the U.S. Coronavirus Aid, Relief, and Economic Security (CARES) Act, which included the Higher Education Emergency Relief Fund (HEERF). The fund provides support to eligible students who have been impacted by the coronavirus pandemic. This relief funding was designed to provide emergency financial assistance to help with technology, course material, housing, and food insecurities. In order to receive the emergency funding, Howard Community College (HCC) submitted the required certification agreeing to use no less than 50% of the funding as emergency financial aid grants to students.

HCC was approved and received initial student relief funding in the amount of \$2.4 million in April 2020 from the Corona Virus Aid, Relief, and Economic Security Act, 2020 (CARES). A second supplemental award amount of \$2.4 million from the Corona Virus Response and Relief Supplemental Appropriations Act, 2021 (CRRSSA) was issued in January 2021 and a third supplemental award amount of \$8.8 million from the American Rescue Plan, 2021 (ARP) was issued in May 2021 for a total of \$13,688,500.

HCC Financial Aid Services will email all eligible students and invite them to complete the emergency relief required agreement within the student self-service portal in place of the previous utilized survey. The agreement is a self-certification that the student has been impacted by the pandemic. Students who accept the agreement will be reviewed for possible awarding of emergency relief funds.

In addition to the agreement, students who are enrolled at the time of awarding in at least one registered credit hour are eligible to receive the relief funding. For the purposes of awarding each semester, students with exceptional need will be prioritized by ensuring all pell students are awarded first and given a larger amount of relief funds.

Award amounts are determined based on the number of eligible students and the allotment utilized for that period of awarding. We will continue to award emergency relief funds through the Spring 2022 semester or when we have exhausted our allotment, whichever comes first.

HCC Financial Aid Services will email all eligible students and invite them to complete the emergency relief required agreement within the student self-service portal in place of the previous utilized survey. Students enrolled in at least 1 registered credit hour with an accepted agreement on file at the time of awarding will be reviewed for possible awarding of emergency relief funds.
