Background: This report addresses the board end, *Measurement, Analysis, and Knowledge Management*. Monitoring measures were selected by the board and include the required Maryland Higher Education Commission (MHEC) indicators.

Highlights:

- HCC's **59.3** percent graduation/transfer rate **exceeded** the state and the peer averages (**49.9** percent and **53.3** percent, respectively) for developmental completers.
- **62.5** percent of Pell grant recipients were retained fall-to-fall **exceeding** the state and peer averages (**53.3** percent and **53.9** percent, respectively).
