



# ARTICULATION AGREEMENT between HOWARD COMMUNITY COLLEGE and UNIVERSITY OF BALTIMORE ROBERT G. MERRICK SCHOOL OF BUSINESS

Howard Community College and the University of Baltimore recognize the need and importance of facilitating the transfer of students from Howard Community College to the University of Baltimore as these students pursue their educational goals. To enhance this transition, a formal articulation agreement between Howard Community College and the University of Baltimore is being established. It is based on a thorough review of the General Education Core Curriculum at Howard Community College and the University of Baltimore in parallel Business Administration programs.

#### ACADEMIC AGREEMENTS

A. A Howard Community College student will be required to complete the requirements for an Associate of Arts Degree with a minimum of a 2.0 Quality Point Average (QPA) on a four point scale.

The University of Baltimore will:

- 1. have all articulated credits applied to the major, and may complete a Bachelor's degree at the University of Baltimore within two years (four semesters).
- 2. award students full junior status with the completion of a minimum of 56 credit hours earned at Howard Community College.
- 3. accept the transfer student's G.P.A. as calculated by Howard Community College.
- 4. honor the Howard Community College Transcript Evaluation Process.
- B. Appointed institutional representatives at Howard Community College and the University of Baltimore will insure that appropriate personnel in their respective colleges are aware of this

agreement, including the admissions and advising staffs, transfer coordinators and appropriate faculty and deans.

C. Appointed institutional representatives from Howard Community College and University of Baltimore will determine course-by-course equivalencies to facilitate the transfer of students from Howard Community College to the University of Baltimore.

#### STUDENT SERVICES

- A. Students will be treated on an equal basis with native students in regards to the award and distribution of financial aid, campus housing, course selection, registration and other student services
- B. The University of Baltimore will provide information and assistance to students interested in matriculating to the University of Baltimore at Howard Community College.
- C. Howard Community College will distribute information regarding this articulation agreement to Howard Community College students interested in pursuing a Bachelor's degree in business.

#### **SCHOLARSHIPS**

Students transferring from Howard Community College to the University of Baltimore, who have earned an Associate of Arts degree, meet application and registration deadlines, academic and financial qualifications that apply to all students are eligible for available Transfer Scholarships. These scholarships include:

#### Wilson Scholarships:

Amount: 100% of tuition per academic year for Maryland residents

Requirements: GPA of 3.5 or higher (across all institutions attended), must maintain 3.25

GPA or higher at University of Baltimore

Award Period: 4 semesters, excluding summers

#### Phi Theta Kappa Scholarships:

Amount: 75% of tuition per academic year for Maryland residents

Requirements: GPA of 3.5 or higher (cross-institutional), must maintain 3.25 GPA or higher

at University of Baltimore

Award Period 4 semester, excluding summers

#### Dean's Scholarships:

Amount: 50% of tuition per academic year for Maryland residents

Requirements: GPA of 3.25 or higher (cross-institutional), must maintain 3.0 GPA or higher

at University of Baltimore

Award Period: 4 semester excluding summers

#### Part-Time Scholars Program

Amount: 50% of tuition per academic year for part-time students

Requirements: GPA of 3.5 or higher (cross-institutional), must maintain GPA of 3.25 or

higher at University of Baltimore

Award Period: 8 semesters for 6-11 credits per semester, excluding summers

This agreement becomes effective upon signature by all parties and shall continue in effect unless voided by either party upon sixty (60) days prior written notice. Howard Community College and University of Baltimore will consider, in good faith, any amendments proposed by either party; however, the Agreement may only be amended in writing, signed by both parties.
