For over 50 years, Howard Community College (HCC) has provided pathways to success by offering quality education to our community at an affordable price. With generous donors like you, the Howard Community College Educational Foundation (HCCEF) can keep providing funding, support, and scholarships to meet students where they dream.

We are proud to report on two fiscal years. In fiscal year 2022, we surpassed our goal of \$1.6 million, by raising over \$2 million. Even more impressive, in fiscal year 2023, we raised \$3.9 million, vastly exceeding our \$2 million goal. It is important to remember that while we might live in an affluent county, some people in our community still struggle and are exploring education to secure a brighter future for themselves and their families. Fortunately, thanks to our generous FY 22 and FY23 donors, the HCCEF has provided \$5,464,881 for student scholarships, programs, and grants from the foundation to the college.

During the same two-year period, HCCEF events generated net revenue of over \$739,000. Fundraising events are critical to the success of HCCEF efforts, introducing new supporters to the college and the foundation, connecting like-minded organizations, and growing the network of support for our students and the college. Undoubtedly, the continued support for HCCEF events illustrates the inspiring dedication of our donors, event sponsors, and community.

As I end my term as chairperson for the HCCEF board of directors and begin serving as an HCC board of trustee member, I am proud of all of our accomplishments and look forward to the continued collaboration with passionate groups of individuals committed to students' ongoing success.
