## 5. Important Guidelines

- Students must have a valid social security number and meet at least one of the Maryland residency requirements listed under section 2 above. HCC reserves the right to adjust or cancel your scholarship at any time if it is determined that you do not meet the qualifications.
- The MHEC Workforce Development Sequence Scholarship funds are available on a first come first serve basis. Applying for the scholarship does not guarantee an award. Contingent on the availability to the applicant of other funds, and whether the student has received the award previously. Award prioritized based on the workforce needs of the service area of the college.
- Some programs have additional eligibility requirements; if applicable, students must apply for and be accepted into the requested program to qualify for the Sequence Scholarship.
- Scholarship awards must be used in the award year.
- Scholarship funds can only be used to pay for tuition and fees.
- Students should not expect refunds of unused grant amounts. Scholarship funds not used within three months of being awarded may be cancelled and you will have to reapply.
- Students must keep the college informed of any relevant name, address and phone number changes that will affect our ability to contact you.
- All scholarships are managed and awarded in accordance to the Maryland Higher Education Commission's prescribed guidelines and HCC college policy.
- If you drop any course in the sequence, you will owe the full balance of all courses taken in the sequence.

## 6.
